AMA announces the release of the new CPT[®] 2024 Standard File

The CPT 2024 Standard Data File was released on 9 September 2023. Changes to the Current Procedural Terminology (CPT[®]) code set are decided through an open editorial process to ensure CPT content reflects the coding and data-driven demands of a modern healthcare system. This year's annual update to the CPT code set created 349 editorial changes, including 230 additions, 49 deletions and 70 revisions. With 11,163 codes that describe the medical procedures and services available to patients, the CPT code set continues to grow and evolve with the rapid pace of innovation in medical science and health technology.
