New AMA research on value-based care and the CPT code set

The American Medical Association (AMA), in collaboration with Manatt Health, recently released research on the essential role of the CPT code set in value-based care (VBC). The research findings describe how the CPT code set enables VBC and where there may be opportunities for continued evolution. These insights are the result of market perspectives on how CPT plays into VBC arrangements today, which the AMA gathered through a series of interviews with VBC provider organizations, health plans, integrated delivery systems, health technology organizations, VBC enablement organizations and others.

The independent, transparent and open CPT code development process is driven by direct, interactive input from representation across the health care community to ensure that the CPT codes reflect the latest medical care available to patients. In September, the hybrid CPT Editorial Panel (the Panel) Meeting convened in Albuquerque, N.M. with over 400 in-person registrants and nearly 900 virtual registrants. Robust discussion and deliberation by the 21-member Panel are hallmarks of this complex, physician-led and evidence-driven process.

After each Panel meeting, a document that summarizes the actions taken by the Panel on each of the code applications is published on the AMA website.
